INDUSTRY OVERVIEW.

Solid waste management in India is expected to reach US 13.52 billion dollars by 2025 making India an attractive investment destination for waste recycling technologies.

Talking about solid waste according to CPCB report, Maharashtra tops in solid waste generation by generating over 26,820 tonnes of solid waste per day. In e-Waste sector, Mumbai comes first as it generates an estimated 1,20,000 tonnes of e-Waste per annually.

Sewerage generation is to tune of 61754 MLD in the year 2015 in India as per data, Maharashtra alone accounts for 13 % of India's total sewerage generation. Sewerage treated capacity stand to 22963 MLD wherein untreated sewerage is 38791 MLD. Projected investment in India in Sewerage sector is estimated around US 55 billion dollars.

PUNE SCORES IN WASTE MANAGEMENT.

PUNE city which is now a part of prime minister, **Shri Narendra Modi's** smart cities initiative has made big strides in improving its solid waste management problems in recent years. The success of the "**PUNE MODEL**" of solid waste management is often discussed by activist and concern citizens.

In Pune where the integrated SWM has ensured high (50 – 55 %) segregation at source in a city that generates 1600 – 1700 mtd of waste every day.

A) PMC seems totally committed to 4R's (Reduction, Reuse, Recycle and Recover)

B) Through multiple solutions PMC has combined an integrated approach with decentralised waste management strategy that encourages NGO's, private sector and corporate world. It has 25 decentralised bio-methane plants which produce 600KW electricity.

C) PMC makes it a point to highlight and celebrate those who adopt innovation solutions and practices in SWM and sanitation through awards and recognition.

D) Public-Private partnership is a part of PUNE's success in Waste Management.

PUNE India's eight largest city is on right track to become a SMART CITY.

Sewerage Generation in PUNE city is to tune of 728 MLD.

Existing STP's -- 567 MLD

Proposed STP's -- 383 MLD

PMC is planning for 100 % collection and treatment of Sewerage. Sewerage treatment plant are funded by JNNURM and existing sewerage plant are funded by PMC.
